BLENDED PROGRAMME “PROCUREMENT AS LEVER TOWARDS A SUSTAINABLE AND DIGITAL FUTURE”RESERVED TO MASTER OF SCIENCE DEGREE STUDENTS – **7 positions****1. Introduction**

Within the EU-funded Erasmus+ project on “Procurement: Digital Tools for Sustainable Goals”(ProcToGo), the Blended Programme on “**PROCUREMENT AS LEVER TOWARDS A SUSTAINABLE AND DIGITAL FUTURE**” aims to provide master-level students with hints and a direct engagement on how procurement can be redesigned through digital tools to achieve sustainability goals.

Entirely taught in English, the programme will start with a self-paced module open from July 1st. It will be centered on an on-site week from **August 28th to September 1st 2023** and will see its closure by September 30th with an online presentation of the groupwork results. According to the EU-funding granted to the ProcToGo project, up to seven students from the University of Rome Tor Vergata can be granted the participation to this Blended Programme.

2. Eligibility Criteria

In order to be admitted to the selection students must be regularly enrolled at the Master of Science (laurea magistrale) level to the School of Economics

3. Selection

The selection of candidates will be based on:

- the performance during the Master of Science/Laurea magistrale in terms of marks and credits obtained (GPA)*;
- the English language certificate (at least B2);
- the Curriculum vitae;
- the motivation letter.

*In order to calculate the GPA, the Examination Board will consider the student’s marks and his/her extra-activities that appear on the Delphi system on the date of the deadline for submitting applications. In case of incomplete information (i.e. the exams or extra activities are not registered yet), the students may attach any document issued by the University/Professors assuring the completion of given exams or extra-activities

4. Application

The selection procedure will open on June 14th and the applications must be sent by **June 28th 2023 at 13:00** [by the form on the website https://proctogo.it/blended-programme-in-antwerp-registration-form/](https://proctogo.it/blended-programme-in-antwerp-registration-form/) including

- Curriculum vitae
- English certificate
- Motivation letter

One missing element will affect the applicant's eligibility.

Candidates' evaluation will be carried out by an Examination Board appointed by the School of Economics, Department of Management and Law.

WARNING: in accordance with the art. 71 of the Presidential Decree 445/2000, the Administration will proceed to undertake necessary checks, even sample checks, for any case showing reasonable doubts about the veracity of the statements certified by candidates on their application form.

5. Expenses

According to the Erasmus+ ProcToGo project, each selected student will be allowed a cost reimbursement up to 58€/day as individual support (hotel and meals) and up to 275€ for total travel costs. On top of this, the University of Antwerp will arrange the lunch buffet during the classes.

6. Assignment and Acceptance

All the participants will be contacted by mail with the results of their application by **July 5th 2023**.

Students will have 7 consecutive days from the issue of the aforementioned list to confirm their participation, by sending an e-mail to info@proctogo.uniroma2.it.

7. Privacy Policy
